**IV. PUBLIC HEARINGS**

**A. MOTION: M/S HUNTER / KELSEY, AND CARRIED BY A UNANIMOUS VOTE OF 5-0, THE COMMISSION APPROVED LAFCO FILE NO. 0634, THE SPADAFORE DETACHMENT FROM THE CENTRAL CALIFORNIA IRRIGATION DISTRICT BASED ON THE FOLLOWING DETERMINATIONS AND WITH THE FOLLOWING ACTIONS: 1. MAKE ENVIRONMENTAL DETERMINATION; 2. MAKE THE SEVEN DETERMINATIONS FOR THE ANNEXATION; 3. ASSIGN THE DETACHMENT THE SHORT FORM DESIGNATION, "SPADAFORE DETACHMENT FROM THE CENTRAL CALIFORNIA IRRIGATION DISTRICT"; 4. APPROVE THE ANNEXATION AND DESIGNATE STAFF TO COMPLETE THE PROCEEDINGS WITHOUT FURTHER NOTICE, HEARING, OR ELECTION.**

**B. REQUEST WAS RECEIVED FROM THE ATTORNEY REPRESENTING THE KIPER ANNEXATION, ASKING THAT LAFCO WITHDRAW THE APPLICATION AT THIS TIME, AND THAT THEY MAY RESUBMIT AT A LATER DATE. SCOTT MCBRIDE, CITY OF ATWATER, ALSO SUBMITTED A LETTER REQUESTING THAT THE KIPER ANNEXATION BE WITHDRAWN.**

**THE CITY OF ATWATER WILL COME BACK AT THE JANUARY 25, 2007, REGULAR MEETING TO DISCUSS THE SEWER CAPACITY FOR THE CITY OF ATWATER.**
